Our goal is to not only take care of the families in need, but to also have a complete and thorough record of information on each individual that goes through the Medical Examiner's office. We maintain a record keeping system on software provided by the Tuscola County Health Department in order to produce our annual report.

Cremation as an alternate means of disposition continues to be a choice many families and individuals request. All cremations permits must be approved by the Chief or Deputy Medical Examiner. A permit is typed, recorded and a fee of \$10.00 is collected for each cremation authorized.

We continue to maintain a productive and cooperative relationship with the Sheriff Department, local Village Police and the Michigan State Police. Many of the officers have and continue to take extensive Medical Investigation training in order to fulfill this role to the best of their ability. We appreciate their dedication to this program.

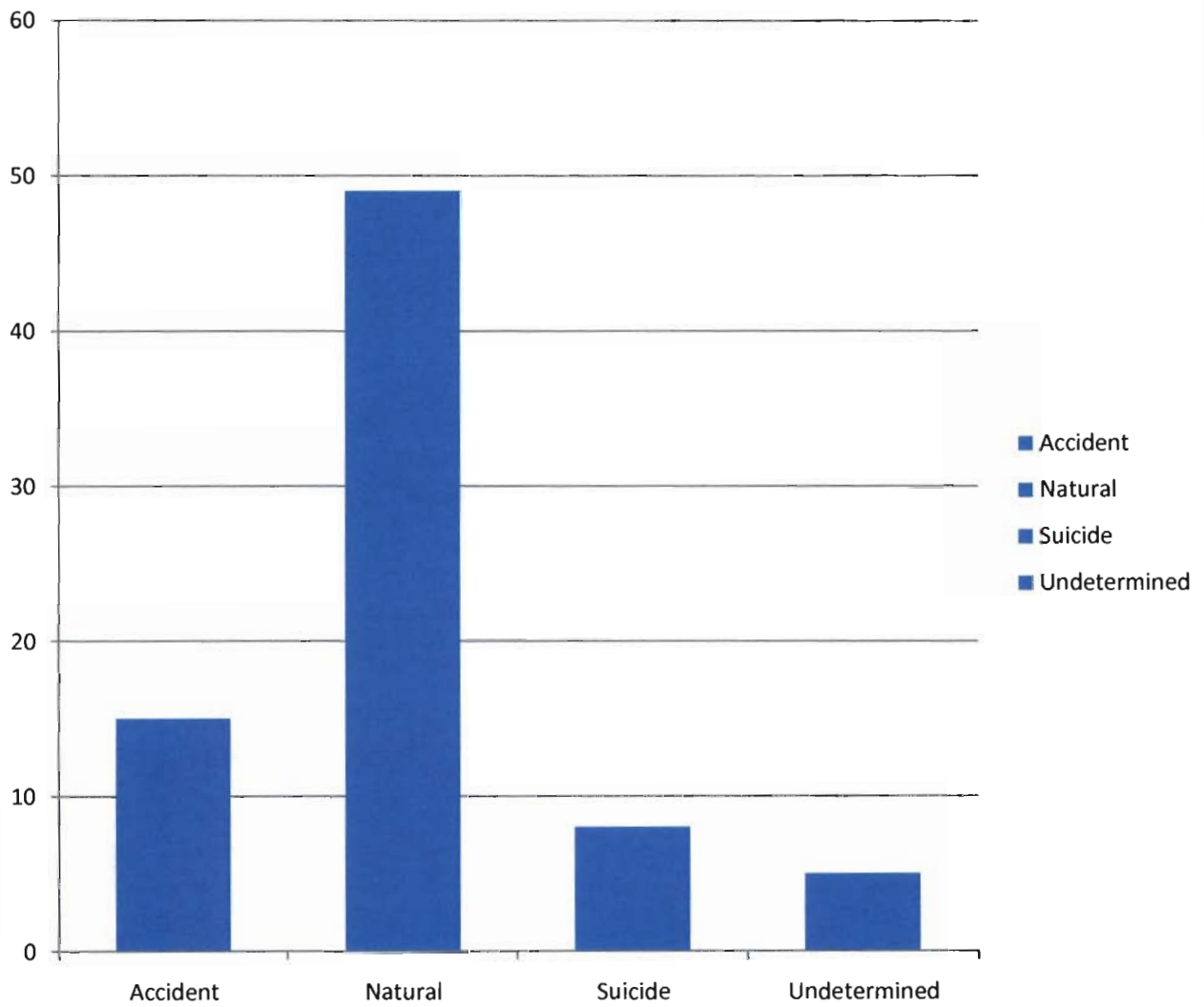

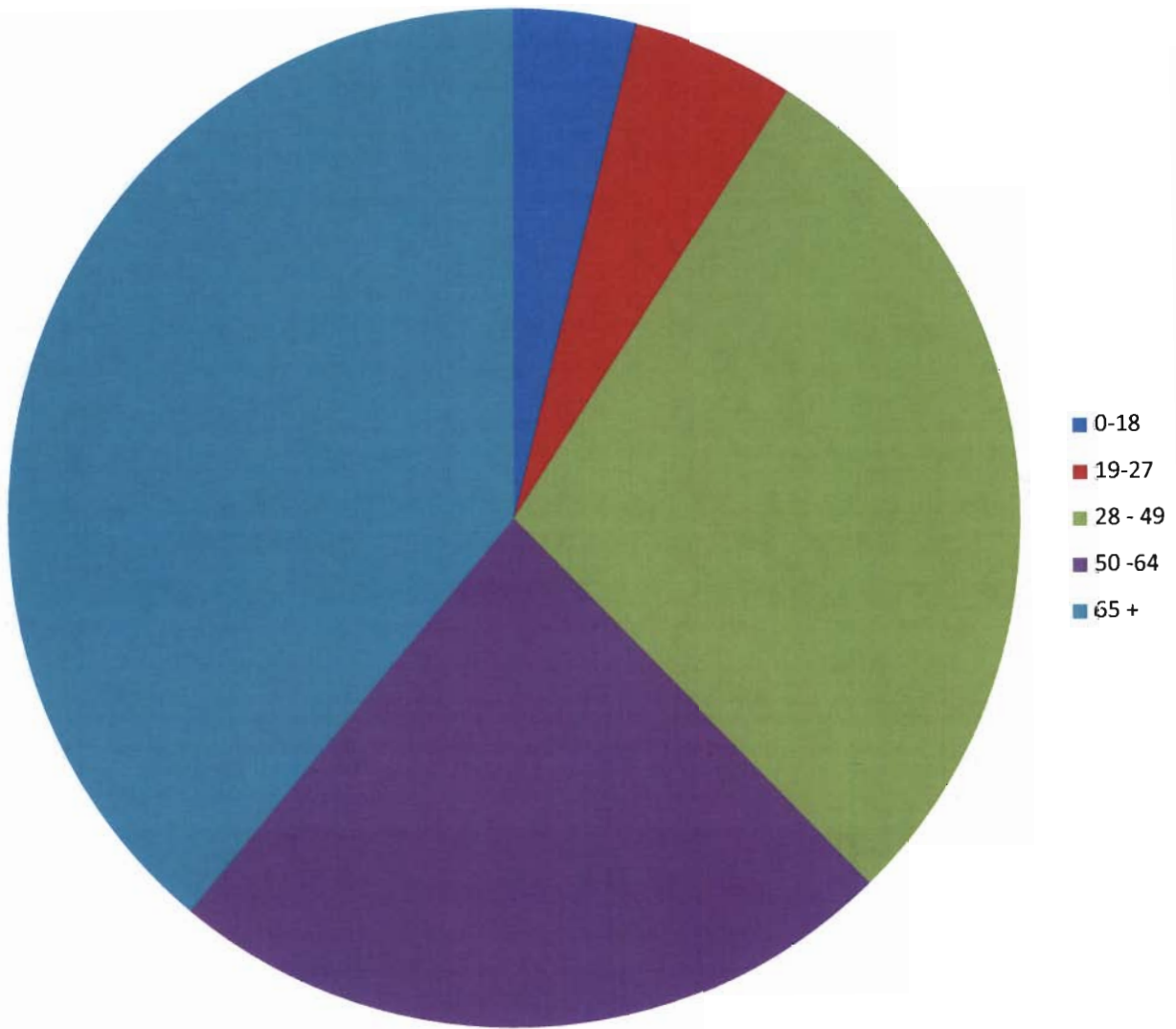
